Victim states that on 1.20.07, he went out on his property to start up his 1963 International dump truck to haul some firewood. When the victim went to start the truck up, the truck would not start. The victim did some investigating as to why his truck would not start. When the victim opened the hood of his truck up, he discovered

that the distributor cap and wiring harness that connected it to had been stolen. While looking at this motor, he found a note from above listed suspect that stated his bus had broken down and he needed a distributor move it. The note goes on to say that he took the victim's distributor and would either pay for it or replace it.

The suspect left a phone number on the hand written note as well as 704.231.1497. The victim contacted the suspect and advised him that what he, the suspect, did was illegal and told the suspect that he would give him until 1.24.07 to pay \$400 so the victim could replace the parts. see next page\*\*\*\*\*\*\*\*\*\*\* The suspect stated that was outrageous and the victim has not heard from the suspect since. RO called the telephone number left by the suspect and asked his side of the story. The suspect advised RO that on the weekend of Thanksgiving of last year his bus had broken down on the interstate. The suspect was advised by SCHP to move it within 24 hours or they would tow the vehicle. The suspect then stated that he had observed the victim's truck before in a field and went to the victim's property and attempted to locate someone to inquire about the parts he needed. When the suspect could not locate anyone, he stated that he took the parts he needed to get his bus running and left the left the note that the victim provided RO. The victim also produced invoices showing prices that he paid to have the parts replaces. Copies of the invoices as well as the hand written note from the suspect were taken and placed into evidence - RO will obtain a warrant for the suspect.
